There were two homicides in Richmond in the monh of March.

Overall, the crime rate for Part I crime (violent & property) is **up 8.28%** YTD citywide. Violent crime is **up 13.41%** for the same period, and property crime is **up 7.47%.** Comparing March 2012 to February 2012, violent crime decreased by 5%, property crime decreased by 11%, and total Part I crime (violent & property) decreased by 9.71%. For 2012 YTD vs. 2011 YTD, Part I crime (violent & property) is **up 25.34%** in the Southern District, **up 11.07%** in the Central District, and **down 0.95%** in the Northern District. Comparing March 2012 to February 2012, violent crime had a 30% increase in the Southern District and property crime decreased by 24%. The Central District showed a 24% decrease in violent crime, and property crime is **up 7%** for the same period. Northern District violent crime had a 21% decrease between February and March, and property crimes decreased by 11%.

There were 13 aggravated assaults in the Southern District for the month of March. **Aggravated assaults increased** compared with last month, and overall they are **up 25% 2012 YTD** compared to 2011 YTD. Two of the assaults this month and 3 of the assaults last month involved the use of firearms. Homicides **decreased by 33.33% YTD, compared to 2011 YTD.**

There were 11 robberies this month compared to 6 last month, reflecting an **83% increase**. Seven of this month's Robberies were armed robbery, compared to 2 armed robberies in February. Robberies are **up 9.09%** compared to last year at this time.
