PUBLIC HEARING

The City Clerk announced that it was time pursuant to published notice to conduct a public hearing for the proposed issuance of multifamily housing mortgage revenue bonds for the Lillie Mae Jones Plaza Development in an amount not to exceed \$7,000,000; and consider adopting a resolution authorizing the issuance in an amount not to exceed \$7,000,000 multifamily housing mortgage revenue bonds for the Lillie Mae Jones Plaza Development. Housing and Community Development Director Patrick Lynch gave a review of the item. Mayor McLaughlin declared the public hearing open. There were no public speakers. On motion of Boardmember/Councilmember Viramontes seconded by Boardmember/Councilmember Ritterman closed the public hearing by the unanimous vote of the Boardmembers/Councilmembers. On motion of Boardmember/Councilmember Viramontes, seconded by Boardmember/Councilmember Ritterman, adopted **Resolution 50-09** by the unanimous vote of the Boardmembers/ Councilmembers.

A proposed resolution authorizing the creation of a Single-Purpose Entity for the Neighborhood Stabilization Program (NSP) was presented. Housing and Community Development Director Patrick Lynch gave a review of the item. Vernell Crittendon, Lynette Gibson-McElhaney, and Kevin Hampton gave comments on this item. Following discussion, a motion was made by Boardmember/Councilmember Ritterman, seconded by Vice Chairperson/Vice Mayor Lopez to approve the item. Chairperson/Mayor McLaughlin requested a friendly amendment to make the process is transparent with looking at different areas of the City. The amendment was accepted and **Redevelopment**
