




Mayor and Members of the City Council:

This is the weekly report for the week ending December 11, 2015.



1. Meeting Notes

The next City Council meeting is scheduled for Tuesday, December 15th beginning with a closed Session at 5:00 PM, followed by the Special City Council Study Session at 5:30 PM, the Joint Powers Finance Authority/Richmond City Council meeting at 6:15 PM, and with the regular City Council agenda commencing at 6:30 PM. The agenda may be found by clicking this [link](#). Please note that this is the final scheduled meeting for 2016; the first City Council meeting in 2017 is scheduled for January 12th.

2. City Offices Holiday Closure 2015

As has been the case during the past three years, as a cost saving measure and with the cooperation of our bargaining units, the City offices, Library and Recreation will be closed during the holiday week in December, beginning Thursday, December 24th, with offices reopening on Monday, January 4th, 2016.

The Police (233-1214) and Fire Departments (307-8031) will remain open, and R-Transit, Public Works, Recreation, and Housing Authority departments will have partial services as outlined below.

R-Transit:

Regular R-Transit services will be available until 5:00 PM on Wednesday, December 23rd, 2015, and will resume on Monday, January 4, 2016.

Between December 24th and January 1st, the Taxi Scrip Program, another transportation service offered through the R-Transit Division, will be available 24 hours per day, as usual. Taxi scrip books must be purchased at the Cashier's Office in City Hall located at 450 Civic Center Plaza on the 2nd Floor no later than Tuesday, December 22nd by 3:00 PM.

3. Annual Fire/Police Toy Program

Every year, the Richmond and El Cerrito Fire and Police Departments hold the annual holiday toy drive for families in need. The toys are all donated by residents like you as well as businesses in and around Richmond. Once collected, the toys are given to families who register for the giveaways. This year's program is set to occur on December 19, 2015.

Today, Richmond Police Officers, staff from Code Enforcement and the Richmond Police Activities League (PAL) visited Parker Hannifin Veriflo Division, a local business that manufactures valves and regulators for the semiconductor industry. This is Veriflo's second year of donating children's bicycles to the holiday toy drive.

Veriflo has 234 employees at their Richmond facility. The employees, along with business partners MKT, NCL and a few others, put their heads and hearts together to buy 245 children's bicycles for this giving event. That's not all! The employees spent their weekend at work building all the bicycles, and they even had a Quality Assurance section to ensure each nut and bolt was snug and the bikes were built up to spec! Talk about giving back to the community!!

Even with generous donations like this, the annual holiday toy program is short on monetary and toy donations. The program is only as successful as the amount of giving hearts in our community. - Participated in a conference call with representatives from the Institute for Local Government and several other cities to discuss a panel presentation at the upcoming League of California Cities City Managers Department meeting;
- Met, together with Assistant Police Chief Allwyn Brown, with new Contra Costa County Animal Services Director Beth Ward;

- Attended the monthly Contra Costa Public Managers Association meeting;
- Attended the meeting of the Berkeley Global Campus Community Working Group.

These meetings were in addition to attending the regular management staff meeting, agenda planning, reviewing staff reports to the City Council, doing department head “check-ins,” having discussions on various personnel matters, and having short discussions with staff, community members, members of the press, etc.



9. City of Richmond Revolving Loan Fund (RLF) Program Receives \$15,000 Grant

The City of Richmond has received a \$15,000 grant from the San Francisco Foundation to support capacity building, marketing and outreach for the Richmond Revolving Loan Fund (RLF) program.

The RLF is a community based program with the goal of fostering local economic growth through the creation and retention of employment opportunities and complementing community development initiatives. The RLF provides loans for working capital, purchase of machinery and equipment, fixed assets (leasehold improvements or renovation), and facade improvements to improve the exterior appearance of a building.

Since the Department of Commerce Economic Development Administration Revolving Loan Fund (EDA- RLF) grant was transferred to the City, 37 loans totaling over \$1.5 million have been approved to Richmond small business owners who had been declined by a bank. The loan funds assisted with creating and saving hundreds of jobs for the Richmond community, and retention and expansion of Richmond businesses.

The loan amounts range from \$5,000 to \$100,000, with the loan cost of \$150.00 for up-front application fee and a 2% loan origination fee at closing.

The Finance Department is reporting that there were a total of 45 new business license filings in the month of November 2015, with 64 jobs created as a result.

11. Hacienda Tenant Relocation Update

In January 2015, the Richmond Housing Authority received approval from the United States Department of Housing and Urban Development for the disposition of the Hacienda public housing development and approval of Tenant Protection Section 8 Vouchers to assist in the relocation of the residents. The Housing Authority has retained the professional firm of Autotemp to provide relocation assistance for the residents. As of the Week ending December 11, 2015 the following relocation activity has occurred:

Autotemp consultants are actively providing ongoing advisory assistance; in addition to the fifty-six (56) completed relocations, thirty-seven (37) Hacienda households have been accepted with approved applications and unit assignments at the newly constructed Harbor View Senior Apartments, with Housing Quality Standards (HQS) Inspections pending issuance of Certificates of Occupancy, bringing the total number of Hacienda residents that have found replacement housing to ninety-three (93). Of the completed relocations, eleven (11) households have successfully

leased-up outside our jurisdiction from Sacramento to Los Angeles and throughout the Bay Area; two of them have successfully leased-up outside the State of California (New Jersey and Arizona).

12. Deadline for Comments on Richmond Bay Specific Plan Is December 15, 2015

The draft Richmond Bay Specific Plan (RBSP), formerly known as the South Shoreline Specific Plan, is now available for public review and comment. The deadline for comments on the draft RBSP is on December 15, 2015.

The RBSP will facilitate the implementation of Richmond's new General Plan by establishing specific planning policies, regulations, and urban design guidelines for an approximately 220-acre area located in the City of Richmond, south of Interstate Highway 580. The RBSP will focus on ways Richmond can take advantage of the planned Berkeley Global Campus at Richmond Bay, future ferry service, and other area assets to create a sustainable shoreline district providing jobs, housing, transportation options, and opportunities for entertainment and recreation. This planning effort is being funded in part by a Priority Development Area Planning Grant from the Association of Bay Area Governments (ABAG) and the Metropolitan Transportation Commission (MTC).

13. Officer Bradley A. Moody Memorial Underpass Project – Unveiling Event Scheduled

With the reopening of all lanes of traffic and sidewalk at the Officer Bradley A. Moody Memorial Underpass, the City has scheduled an unveiling event for Thursday December 17th at 11:00 AM. The event will be held at the project site, on Marina Bay Parkway between Meeker and Regatta. During the event, Marina Bay Parkway will be temporarily closed to vehicular traffic.

14. Nevin Avenue Improvement Project – Next Phase Commencing December 7th

The Nevin Avenue Pedestrian and Bicycle Improvements Project is a reconstruction of Nevin Avenue between 19th Street and 27th Street that will improve aesthetics and safety for travel between the Civic Center and Richmond BART Station areas. The project involves new sidewalks, curb and gutter, streetlights, landscaping and stormwater drainage improvements.

The next phase of work on Nevin Avenue, from 24th to 27th streets, is scheduled to begin on December 7th. During this phase, the eastbound lane of Nevin Avenue will be removed for storm drain installation. This will necessitate demolition of the south side of the street between 24th and 27th streets. During this phase, one way traffic control will be in place and only westbound traffic will be permitted. To avoid the construction area, visitors to Civic Center facilities are encouraged to use the parking lot located at Barrett Ave and 25th Street. The one way traffic control and local street closures will be in place for the duration of work on this phase, estimated to be approximately four to six months.




15. Richmond's Minimum Wage Ordinance

The City of Richmond's Minimum Wage increase goes into effect January 1, 2016. The new minimum wage set forth in the Ordinance will be \$11.52 an hour (compared to \$9.00/hour for the State of California and the initial \$9.60/hour wage initially established in the City on January 1, 2015) and it applies to any employee who works two or more hours per week.

The Employment & Training staff posted notices announcing the increase on KCRT, and the City's website. Packets will be mailed to over 3,000 businesses and the Richmond Chamber of Commerce members to inform them of the change. The information packet includes English and Spanish versions of the official notice that must be posted in all workplaces along with a list of employer and employee rights under the ordinance. Employers who pay for less than 800 hours of employee labor in a given two-week period need not pay the City's minimum wage until they pay over 800 hours or more of employee labor in a two week period. This is the first of three annual increases that will max out at \$13.00/hour on January 1, 2018.







19. Recreation Highlights

20. Public Works Updates

Facilities Maintenance Division:

Carpenters have completed various tasks related to the American Disability Act (ADA) improvements at the Library.

Painters completed the main social room at the Senior Center.

Stationary Engineers restored heat to the Madeline Whittlesey Room of the Main Library, replaced apparatus exhaust motor at Fire Station #64, fixed the freight elevator at the Richmond Auditorium, rekeyed the Washington Field House and serviced the building management system for the Civic Center.
