

ORDINANCE NO. 15-16 N.S.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RICHMOND AMENDING THE CITY'S TRUCK ROUTE DESIGNATIONS AND MAP

WHEREAS, the Cities of Richmond and San Pablo are collaborating on developing bicycle and pedestrian improvements along San Pablo Avenue between Rivers Street and Hilltop Drive;

WHEREAS, the improvements will require the revisions to the intersection of Robert H. Miller Drive, which will make access difficult for large trucks;

WHEREAS, Robert H. Miller Drive is designated as a truck route number 23 in the City of Richmond's Truck Route Map, the current version of which is depicted on the City's General Plan 2030 and is on file in the City's Engineering Department;

WHEREAS, there are alternative routes for large trucks to travel;

WHEREAS, Robert H. Miller Drive noted as truck route number 23 is not necessary to serve the movement of goods within and through the City of Richmond;

WHEREAS, Hilltop Drive from Robert H. Miller Drive to the Richmond Parkway is a suitable truck route;

WHEREAS, the City desires to amend its Truck Route Map to reflect the proposed change described above; and

WHEREAS, the municipal code Section 14.52.030 describes the restrictions on certain streets designated by ordinance as "truck routes."

NOW, THEREFORE, the City Council of the City of Richmond do ordain as follows:

SECTION 1. Robert H. Miller Drive, currently truck route number 23, shall no longer be designated as a truck route.

SECTION 2. Hilltop Drive from Robert H. Miller Drive to the Richmond Parkway shall be designated as a truck route.

SECTION 3. The map attached as Exhibit A to this ordinance depicts the City's updated Truck Route Map, reflecting the changes set forth herein.

SECTION 4. This ordinance shall be effective thirty (30) days after passage and adoption.

First read at a regular meeting of the Council of the City of Richmond held November 1, 2016, and finally passed and adopted at a regular meeting thereof held November 15, 2016, by the following vote:


