1. **Meeting Notes**

2. **North Bay Fire: Support for the Impacted Communities**

Our thoughts – and our hearts – go out to those impacted by the fires in the North Bay. Both the Richmond Fire and Police Departments have deployed units based on the State of California’s mutual aid system to assist in battling these fires.

Richmond residents and employees have inquired about providing assistance to the many families needing temporary shelter from evacuated areas. While City facilities are not currently needed for this purpose, you should know that the City of Richmond Fire Department Office of Emergency Services (OES) is working in concert with the Contra Costa County Sheriff’s Department (OES) and the American Red Cross to stand ready should additional shelter needs arise.

To directly help the fire victims, it is highly recommended that donations be made to the American Red Cross, which assists in providing care and shelter during these types of emergencies. 5. What is Your Vision for the Northshore of Richmond?

The City would like your input on potential land use changes in Richmond's Northshore to complement the existing Dotson Family Marsh (Point Pinole Regional Shoreline), including expanding parks, agriculture institutional, and community facilities land uses. Your input will inform a possible General Plan Amendment in this area.

The City Council recently directed City staff to work with the community on formulating a General Plan Amendment for this area, consistent with their policy direction. Currently, General Plan 2030 envisions Change Area 12 as a low-intensity office/light industrial hub. Privately-owned parcels located near the Richmond Parkway are designated as Low Intensity Business/Light Industrial, while publically-owned properties located along the shoreline are designated as Open Space. The City Council policy is that the General Plan Amendment should evaluate the potential of changing the land use designations of Change Area 12 to some combination of Open Space, Parks and Recreation, Agriculture, and Public, Cultural and Institutional. This could remove the Low Intensity Business/Light Industrial designation from the area.

8. City Manager Chronicles

I have listed below some of the topics for meetings that I attended during the past week in the hope that it provides an idea of the varied issues with which our organization deals routinely.

Meetings and events of note this past week included:

- Met, together with Planning and Building Services Director Richard Mitchell and Planning Project Manager Lina Velasco, with staff from the Department of Toxic Substances Control (DTSC) to review the status of the former Zeneca site soil remediation;
- Participated in a conference call with staff from the Bay Area Council and other Bay Area cities to discuss submittal of a joint proposal for the second Amazon corporate headquarters;
- Met, together with Mayor's staff member Sequoia Erasmus, with a representative from Bike East Bay to discuss their local and regional activities;
- Attended the meeting of the Bike and Pedestrian Advisory Committee;
- Met, along with Planning and Building Services Director Richard Mitchell and Successor Agency consultant Alan Wolken, with developers and planners of the Parcel FM site at Marina Bay to discuss design options;
- Met with HUD (Department of Housing and Urban Development) officials, together with Richmond Housing Authority consultant Tia Ingram, Finance Director Belinda Warner, and Deputy City Attorney Carlos Privat, to discuss Richmond Housing Authority issues;
- Met with a group of CORO fellows to discuss municipal finance issues, along with Finance Director Belinda Warner;
- Attended the monthly Council of Industries lunch;
- Attended the Richmond Promise Board meeting;
- Participated in my monthly "check-in" meeting with West Contra Costa Unified School Superintendent Matt Duffy; and
- Met with representatives from the Safe Return Team to discuss implementation of the Fair Chance to Housing ordinance.

These meetings were in addition to attending the regular management staff meeting, agenda planning, reviewing staff reports to the City Council, doing department head "check-ins," having discussions on various personnel matters, and having short discussions with staff, community members, members of the press, etc.

9. Richmond Promise Scholarship Now Open + Upcoming Workshop on October 30th

The FAFSA/Dream Act and Richmond Promise Scholarship applications are now open.

To be eligible for the Richmond Promise Scholarship, a student must:

- Be a resident of Richmond or North Richmond (i.e. have a Richmond home address);
- Have graduated from an eligible high school within the West Contra Costa Unified School District boundary area or received a GED/high school equivalency between June 2017-2018;
- Have attended an eligible high school at least 9th-12th grade consecutively;
- Have completed the FAFSA/Dream Act by the March 2nd Cal Grant deadline.

10. Richmond Summer Youth Program and California Youth Energy Services

The City recently concluded the Summer 2017 California Youth Energy Services (CYES) program, in partnership with Rising Sun Energy Center and the City's Environmental Initiatives Division and Summer Youth Employment program. The CYES program employed nine Richmond young adults as Energy Specialists who served 223 Richmond residences, providing unlimited LED light bulbs, and other no-cost energy-and water-saving devices, including smart power strips, faucet aerators, and efficient-flow showerheads. In addition to green job training, Energy Specialists participate in weekly professional development workshops that include resume workshops and financial literacy training.

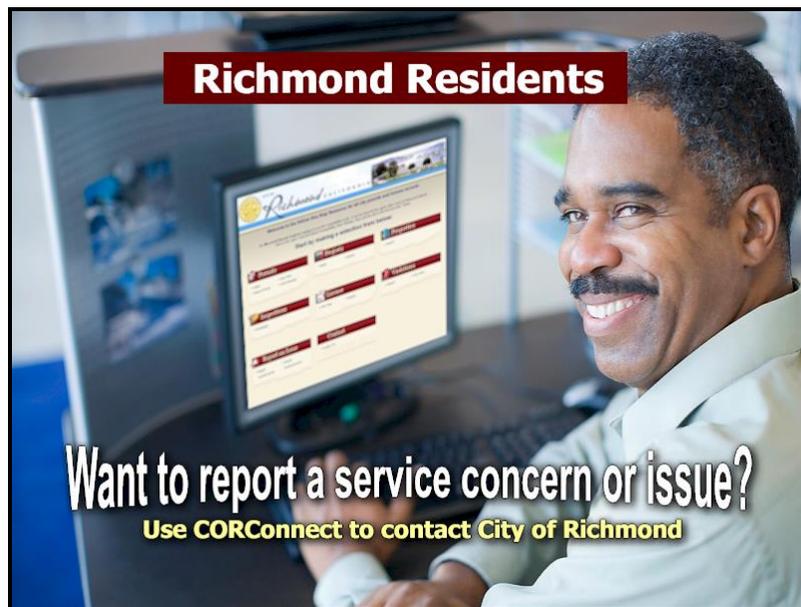
The Richmond Energy Specialists exceeded their goals and led all participating CYES cities by installing 3,714 LED lighting fixtures and 211 advanced smart power strips. The total program outcomes will reduce greenhouse gas emissions by 47 metric tons and reduce water consumption by 1,212,240 gallons of water each year.

Alternatively you can select the **COR Connect** button on any other webpage on the left hand side of the page.



On the next screen under Report an Issue select Report Issue/Concern to create a report or Search Issue/Concerns to look up a previously reported issue. You can also look up previously submitted issues to check on the current status if you provided you name, phone number or email when you submitted it.



On the page, you can also look up information on a parcel, see permits issued and look up business license information. If you have a current business license you can pay to renew it online with a credit card.

The recommended browsers are: **Microsoft Edge**, or **Microsoft Internet Explorer version 11** using the compatibility mode. It can be found in the upper right corner of Internet Explorer: click on the "gear" icon and select Compatibility View Settings, then add the site to the list and click "Close".

Serve Day in Richmond

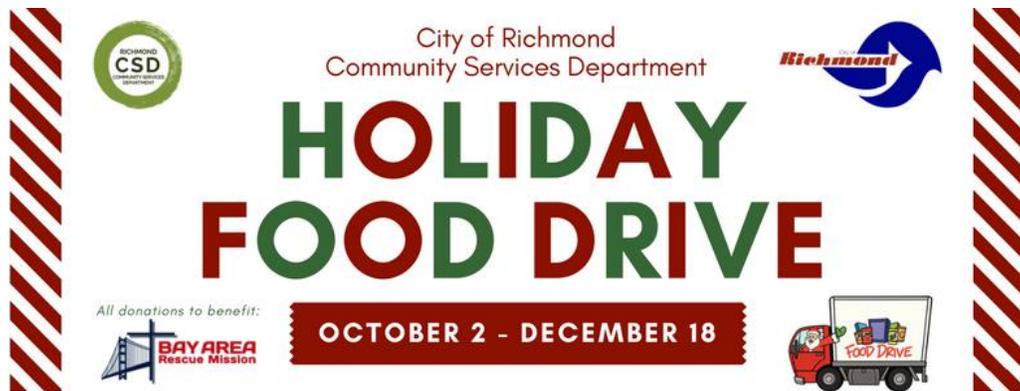

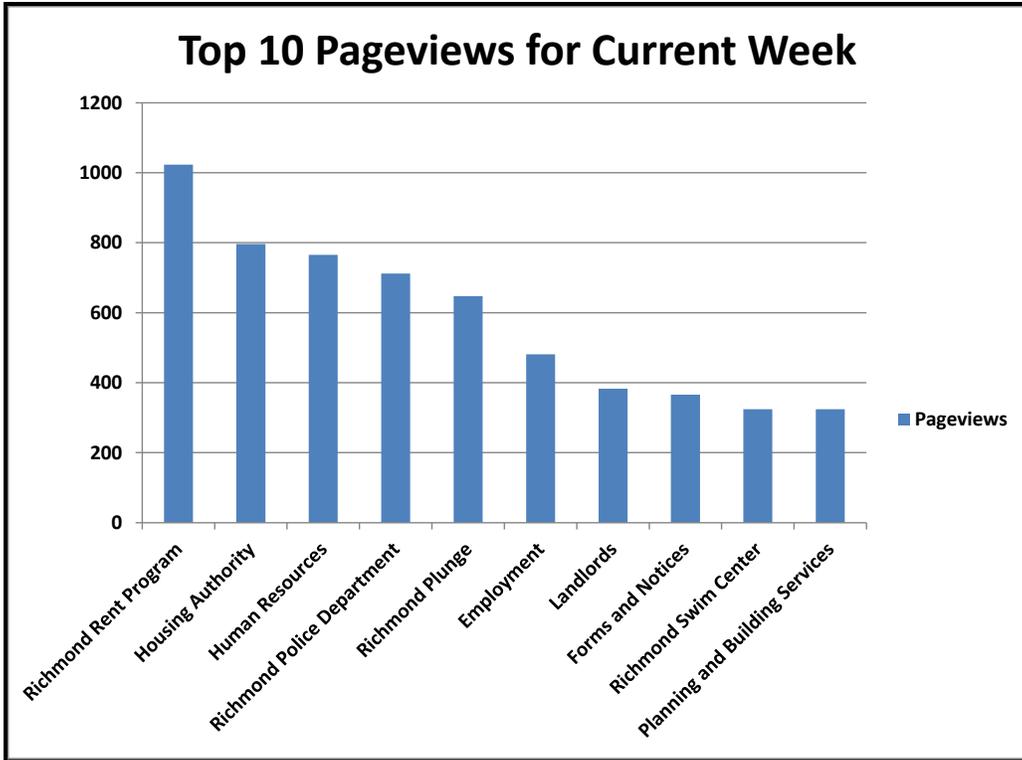

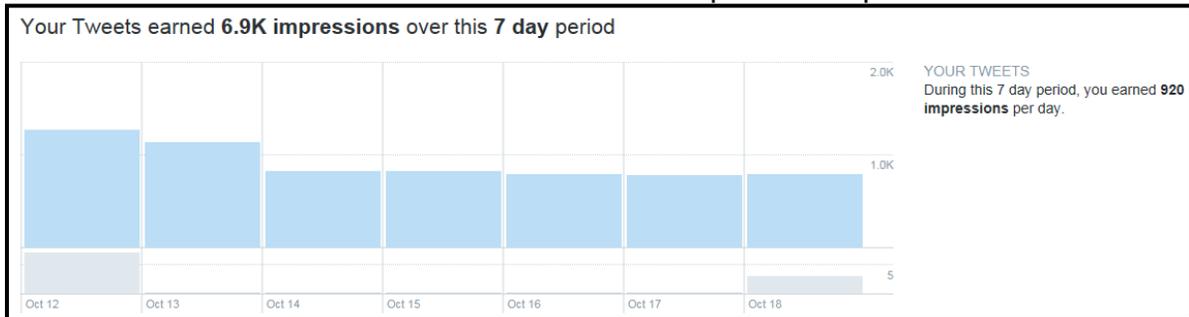

The Rifle Range Road project is progressing well in anticipation of the rain. The driving of concrete is in place and pile work continues on schedule.



Rifle Range Road Reconstruction

I-80 Central Ave. Operations Improvement Project (I-80 and Central Avenue)
