COUNCIL AS A WHOLE

In the matter to appoint a candidate to fill the vacant seat on the City Council that occurred on January 13, 2015, City Clerk Diane Holmes read the item and instructions into record. Lane, Marilyn Langlois, Jeff Lee, Vinay Pimplé, Jim Rogers, David Schoenthal, Kathryn Sibley, and Uche J. Uwahemu. Candidate Samuel Pooler was not present. A motion by Vice Mayor Myrick, seconded by Mayor Butt to appoint *Sheryl Lane* to the vacant Council seat failed by the following vote: **Ayes:** Vice Mayor Myrick and Mayor Butt. **Noes:** None. **Abstentions:** Councilmembers Bates, Beckles, Martinez, and McLaughlin. **Absent:** None. A motion by Vice Mayor Myrick, seconded by Mayor Butt to appoint *Raquel Donoso* to the vacant Council seat failed by the following vote: **Ayes:** Councilmember Bates, Vice Mayor Myrick, and Mayor Butt. **Noes:** None. **Abstentions:** Councilmembers Beckles, Martinez, and McLaughlin. **Absent:** None. A motion

by Councilmember Beckles, seconded by Councilmember Martinez to appoint ***Claudia Jimenez*** to the vacant Council seat failed by the following vote: **Ayes:** Councilmembers Beckles, Martinez, and McLaughlin. **Noes:** None. **Abstentions:** Councilmember Bates, Vice Mayor Myrick, and Mayor Butt. **Absent:** None. A motion by Mayor Butt, seconded by Vice Mayor Myrick to appoint ***Kathryn Sibley*** to the vacant Council seat failed by the following vote: **Ayes:** Vice Mayor Myrick and Mayor Butt. **Noes:** None. **Abstentions:** Councilmembers Bates, Beckles, Martinez, and McLaughlin. **Absent:** None. A motion by Vice Mayor Myrick, seconded by Mayor Butt to appoint ***Rosemary Corbin*** to the vacant Council seat failed by the following vote: **Ayes:** Vice Mayor Myrick and Mayor Butt. **Noes:** None. **Abstentions:** Councilmembers Bates, Beckles, Martinez, and McLaughlin. **Absent:** None. A motion by Mayor Butt, seconded by Vice Mayor Myrick to appoint ***Ben Choi*** to the vacant Council seat failed by the following vote: **Ayes:** Vice Mayor Myrick and Mayor Butt. **Noes:** None. **Abstentions:** Councilmembers Bates, Beckles, Martinez, and McLaughlin. **Absent:** None. A motion by Vice Mayor Myrick to appoint ***Dameion Demon King*** died for lack of a second. The City Council was unsuccessful in appointing a candidate to the vacant City Council seat and ***continued the item to February 17, 2015.***
