## **RESOLUTION NO. 1994**

RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE HOUSING AUTHORITY OF THE CITY OF RICHMOND AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE SERVICE CONTRACTS WITH TWO (2) HOUSING QUALITY STANDARDS (HQS) INSPECTION SERVICE PROVIDERS, STERLING INSPECTION SERVICES AND CMH INSPECTION SERVICES, FOR HQS INSPECTION SERVICES IN AN AMOUNT NOT TO EXCEED \$50,000 PER FIRM PER YEAR OVER A THREE-YEAR PERIOD WITH TWO OPTIONAL ONE-YEAR **EXTENSIONS** 

WHEREAS, the Housing Authority is in need of HQS inspection services and on October 7, 2014, a RFP was posted on the City of Richmond's bids online, with proposals due on October 21, 2014; and

WHEREAS, there were 16 prospective vendors that were notified and the RFP was downloaded by interested parties resulting in three (3) proposals being submitted; and

WHEREAS, the proposals were evaluated by a panel consisting of the Housing Authority Director, Housing Authority Assisted Housing Manager and a Building Inspector from the City of Richmond; and

WHEREAS, of the three proposals submitted two, Sterling Inspection Services and CMH Inspection Services, were rated higher with noticeable distance from the lowest rated proposal, and both were highly qualified based on the RFP selection criteria; and

WHEREAS, the RFP provides that the Housing Authority may select one or more bidders and both firms were determined to be responsive and responsible to provide the services needed, and fully capable of undertaking the scope as outlined in the RFP;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE HOUSING AUTHORITY OF THE CITY OF RICHMOND, COUNTY OF CONTRA COSTA, STATE OF CALIFORNIA, THAT:

The Executive Director is hereby authorized to execute contracts with Sterling Inspection Services and CMH Inspection Services to provide HQS inspection services for an amount not to exceed \$50,000 per firm per year over a three-year period with two optional one-year extensions, and the Executive Director is hereby authorized to take all actions necessary to implement the foregoing resolution.
