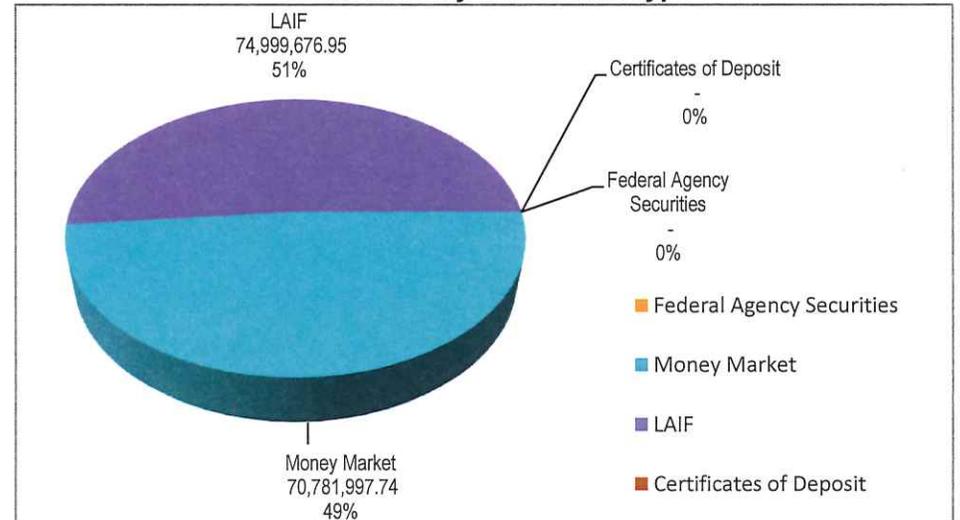
Book Value History
