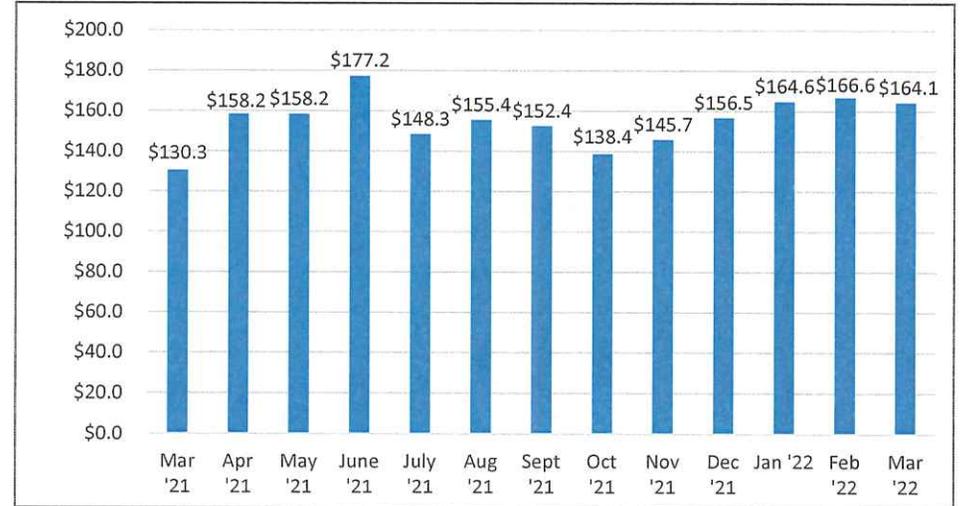

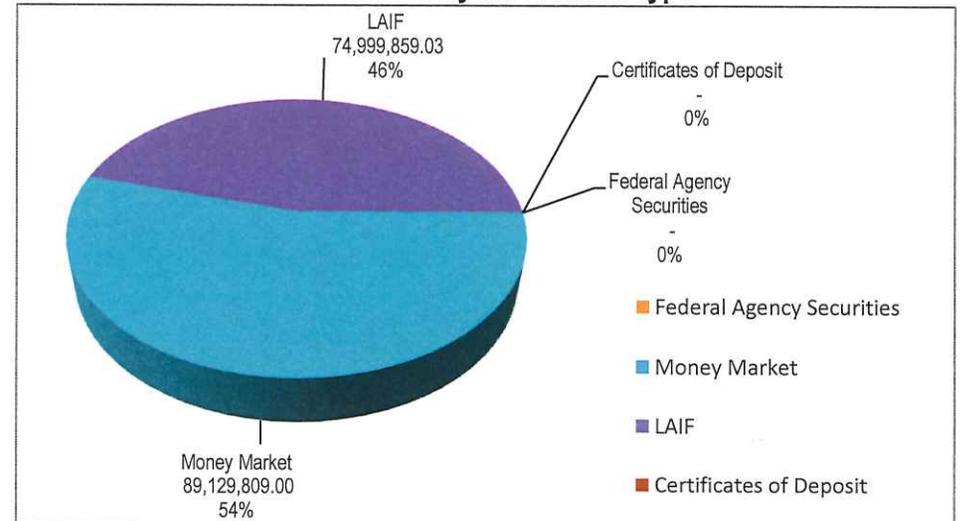
**Book Value History**  
(in millions)

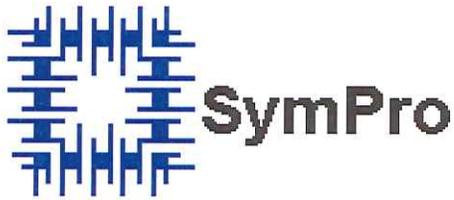

**Book Value by Investment Type**





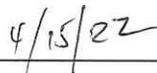
